APPLICATION AND DEADLINES

Applicants should submit the below information **in English** by **16 December 2022, 23:59 Singapore time**. They will be notified about the Fellow selection decisions by early February 2023.

The following must be submitted:

- 1) A personal statement describing what would be the applicant's goals as a member of the Organizing Committee and how they could contribute to APACC (<500 words);
- 2) A letter of support from a mentor, department chair, or supervisor to describe the applicant's current scope of work, confirm eligibility to apply (per the above criteria), and comment on the candidate's suitability for the fellowship program;
- 3) A current CV.

All application documents must be in English and should be submitted as electronic files to Yee Ning Tham (yeening.tham@amededu.com). Review criteria for selecting Fellows include clinical and/or research experience with HIV and co-infections in the Asia-Pacific region and prior experience actively participating in research conferences (e.g., presenting at local or international meetings).

ELIGIBILITY REQUIREMENTS

- 1) Early career investigator, as defined by: a medical degree (MD, MBBS) or PhD in a health-related field in the past ten years (if in an academic institution, holding a position up to the level of Assistant Professor, or comparable title);
- 2) Living in one of the below eligible countries*;
- 3) Submission of a complete application by the deadline;
- 4) Commitment to participate in and implement program activities.

Eligible countries*:

American Samoa, Australia, Bangladesh, Bhutan, Brunei Darussalam, Cambodia, China (including Hong Kong SAR, Macao SAR), Commonwealth of the Northern Mariana Islands, Cook Islands, Democratic People's Republic of Korea, Federated States of Micronesia, Fiji, French Polynesia, Guam, Hong Kong, India, Indonesia, Japan, Kiribati, Lao People's Democratic Republic, Macao, Malaysia, Maldives, Marshall Islands, Mongolia, Myanmar, Nauru, Nepal, New Caledonia, New Zealand, Niue, Palau, Papua New Guinea, Philippines, Pitcairn Island, Republic of Korea, Samoa, Singapore, Solomon Islands, Sri Lanka, Taiwan, Thailand, Timor-Leste, Tokelau, Tonga, Tuvalu, Vanuatu, Vietnam, Wallis and Futuna
